Specialized software, supporting multiple languages over a private network, will provide travel and location based applications for cultural exchange between international travelers, Hawaii businesses, the Hawaiian community, Asia, and North American networks.

SGB is founded by technical entrepreneur and CEO/Chair Edward BT Sun. He was a former executive with GTE, Hewlett-Packard, General Electric, Aquasearch Corp., Advanced Technology Systems, Computer City, FiberDuct Solutions, Optimus Corporation and VeriFone Inc.
